1 / THEME

2 / PARTICIPANTS

People of different nationalities and ages.

3 / RECEPTION OF WORKS

3.1. The delivery period will finish on **January 12 th 2016**. Applications must be accompanied by the following information: name, age, address, email and telephone and sent to **contacto@fundacionnmac.org** with the subject: “Migratory Flows”.

3.2 . The photograph (one or two works per person) should be attached in JPG format, with 240 ppp resolution and no larger than 20 x 20 cm. Each file will be named with the title of the work.

4 / JURY AND SELECTION

4.1. The jury is formed by The NMAC Foundation team.

4.2. All selected works will appear in The NMAC Foundation's profile on flickr.

5 / FAIL

After the contest, the jury will select the winners based on quality criteria, approach to the subject of “Migratory Flows” and originality.

Winners will be notified on **January 19 th 2016**.

6 / AWARDS

6.1.

- **First prize:** NMAC friend card valid for a period of one year and all publications of The NMAC Foundation.

- **Second prize:** Two catalogs of The NMAC Collection and a guided tour to the light sequence in "Second Wind 2005", James Turrell piece at sunset.

- **Third prize:** Catalogue of "Second Wind , 2005" by James Turrell.
